Discussion:

Several accountants (ULTIMATE NL members) advised that ULTIMATE NL does not need to look back 7 years finance for the tax because ULTIMATE NL yearly revenue is low (lower than \$40,000) and there is no tax from grants. ULTIMATE NL just needs to file the Non-Profit Organization Information Return (T1044) each year.



- Therefore, it is important for ULTIMATE NL to collect its own fees, instead of having MZU, or other leagues to collect part of ULTIMATE NL fees.
- How to make it work?
